

#### **Your Board in Action**

Summary of GSHA Board Meeting of October 18, 2018 by Jeanette Martinez, Secretary

All board members were present including the new GSHA-Utah Chapter Representative, Margie Delgado. The board welcomed three guests: Rose Alvarado and Gloria Gonzalez-Cook of the UT Chapter and SC Member Cathy Romero.

Vice-President, Charlene G. Simms, submitted a written report and stated there is a correction to the number of households for the Utah Chapter which should be 27, not 276. GSHA has 472 members total.

Treasurer, Bob Craig, submitted a projected 2018/19 budget which showed we are \$1,117.05 in the red. Because we begin getting memberships early in November and December, we will probably finish 2018 on the positive side.

For the GSHA Annual Business Meeting and Conference Report, Bob noted a few reasons we were able to make a profit this year of \$12,839.00: 1) Because we were able to use library-owned equipment, there were no Audio/Visual equipment costs; 2) We had no conference room rental expenses; and 3) Great fundraising efforts and donations, saving GSHA approximately \$6,000 - \$7,000.

After lengthy discussion, the board voted to distribute conference profits as follows: 1) that of the 2018 conference profits, GSHA keeps all profits except \$1100 for future expenses; and 2) that the GSHA Board presents \$1000.00 each to the FACC and SC Chapter. This topic will be revisited in 2019 to address sharing conference profits with the Utah Chapter.

Chapter reports presented by Patsy Vasquez for SC and Mary Ellen Burciago for FACC indicated both Chapters are doing very well and looking forward to 2019 meetings and activities.

The four GSHA-Utah Chapter members present informed the board during their September 8<sup>th</sup> Chapter meeting it was decided a core group will continue to work together to make Utah a viable chapter. For the time being, Margie Delgado, Rose Alvarado and Gloria Gonzalez-Cook will work on putting a new board of directors together, recruit new members, plan their agenda for the year and get the Chapter back on a track for success.

Member-at-Large representative, Arturo Cuellar will be attending two speaking engagements, one in Las Vegas, Nevada and the second in Mexico City, Mexico. He plans to promote GSHA and seek new members in those areas.

2018 Conference Report: Charlene reported the conference was financially successful. Everyone who attended seemed very pleased.

GSHA Website: GSHA has received a proposal from Eduardo Griego to design and build a new, more user-friendly website. They will be reviewing his and other proposals. The board is also soliciting comments and ideas from the chapters to improve the website.

Board members voted to use the video conferencing site called ZOOM to host future board meetings. The cost is less than the current service and many more members can participate.

• President, Frank Dominguez, reminded board members a motion was made and passed at the July board meeting that we form a committee to explore the ways and means of transitioning to a PDF version of our journal, *Nuestras Raices*, and to assure its distribution only to dues paying members.

The updated GSHA Bylaws, which include changes approved by members in July, have been posted on the website.

Chapter representatives were asked to report to the board any nominations for Honorary and/or Lifetime members by January 2019. [See GSHA Bylaws, Article III, Section D, Paragraph 2.]

The board received a request from FACC member, Tom Martinez, to change the membership year from January to December, for memberships to begin on the month of joining. It was decided after discussion that this would require a change to the bylaws, and if Tom wants to pursue this, he needs to submit a bylaws change form to the board.

Margie Delgado stated the 2019 RootsTech Conference will be in Salt Lake City February 27th to March 2<sup>nd</sup>, 2019. It's a great conference and includes a lot of exhibits. She hopes many GSHA members will attend.

## Fray Angelico Chavez Chapter takes a trip to the past



Twenty years ago, in 1998, the FAC Chapter in Pueblo was instrumental in raising \$8000 to get an artist to create a plaque to honor the people who were killed in the 1854 Christmas Tragedy at El Pueblo trading post. Eleven New Mexican occupants, and four Ute men were killed. Two boys and Chepita Miera were kidnapped. She was later killed. One boy was returned eight months later and the other boy was returned 5 years later.

Dr. Heraldo Acosta, a member of FACC, wrote a successful \$5000 grant and FACC members generously donated an additional \$3000 to complete the plaque. Shown to the left is Dr. Acosta with the finished product in 1998. Pictured at the bottom are Richard and Vicky Arellano and granddaughter, Michelle and Heraldo, Betty Duran and Bob Craig, all donors to the plaque. El Pueblo Museum held a candlelight vigil for those who died in the tragedy and honored all the FACC donors.





#### Status Of GSHA 2019 Annual Business Meeting and Conference

At the end of the 2018 conference we announced that the next conference would be in Santa Fe and we needed a chair person or co-chairs to come forward so they could start planning the conference. To date, no one has come forward to plan the 2019 conference. Meanwhile, we learned through Doug Daniels, who has in the past negotiated with the Drury Plaza some very affordable lodging prices, that they are now under new ownership. The lowest price he could negotiate is \$209 a night which is twice as much as we have had to pay in previous years and other costs at the Drury have also gone up.

So since we have no co-chairs and the price at the Drury is prohibitive for this year, one of our FACC members recommended we have the conference in Pueblo for a second year. I was able to secure the library again for August 2-4 with a variation in the agenda. However, people from California really want it in Santa Fe, so a group of them led by Patsy Vasquez are going to discuss this very soon and see if they can come up with a plan for Santa Fe. Lenny Trujillo, president of the SC chapter has indicated that they prefer to host the conference in 2020.

Meanwhile, some of our Utah members have found that there is a venue in Espanola and they, too, are doing some research and leg work and will report back to the board as to the possibilities there.

Nevertheless, we still need co-chairs. Please contact me at charlenegsimms@yahoo.com if you are interested in being a co-chair. Jeanette Martinez, Bob Craig and I will be available for any questions and advice on how to proceed with each co-chair's duties.

At the FACC meeting on January 12 Bob Craig and I broke down the duties of the three co-chairs. While we got many people to volunteer for some of the tasks and duties at the conference, no one came forward to volunteer as a co-chair nor has any chapter offered to host the conference which gives the them the opportunity to earn an additional 25% of the cleared profit.

The following are the duties of each co-chair. Please note that a conference manual guide was prepared two years ago by Jeanette Martinez and Charlene Garcia Simms that outlines all that has to be done for a successful conference from A — Z. Last year we developed a template wherein the chair or co-chairs can just fill in the blanks.

- 1. Speakers, entertainment, agenda co-chair: Once a theme is decided upon this co-chair looks into different speakers on the topic selected. There are several places to look for these speakers and these are listed in our manual. Most cities or towns have a pool of very talented people who can sing, dance, act, etc. The agenda is a schedule and a model has already been developed. Tours are arranged on Friday during the day. The President's reception is in the evening. Saturday is lined up with speakers, workshops and other learning activities. Saturday night is the banquet and in the past a "dress as your ancestor," contest has become very popular. Sunday is again filled with speakers and learning activities, and the conference concludes by 4 p.m.
- 2. Vendors, Donors, Raffle co-chair Again, all duties are explained in the manual. We already have a built-in list of vendors who are asked every year and depending on the location, new ones are added every year. Last year we had more donors than ever before and also with the vendors, we have a built in list of people that can be asked, and we can develop new vendors. The raffle is one of our most popular activities, and we have already have someone from the California chapter who helps us gather the large raffle items from several large corporations. Other raffle prizes come from our generous members. In the last few years, Vicky and Richard Arellano's family has helped manage this activity. Hopefully, the Arellanos can help again next year, or we can get other volunteers.
- 3. Lodging Facilities, food co-chair (reception, continental breakfast, list of restaurants for lunch, lunch on Sunday, Banquet and snacks.) The person who takes care of all this is probably the most important person for the entire conference because as we say, *Panza llena, Corazon contento* (a happy belly, makes a happy heart). Food is very important. We can use the same caterers as last year or get new ones.

These are the three positions that we need to fill in order to make the conference successful. You are not going to be left alone and thrown to the wolves. We have a conference manual that lists the steps that need to be taken care of; we have last year's co-chairs to help; we have amazing volunteers, members and non-members that will not let you down. Won't someone out there take the challenge, to help us coordinate another successful conference?

At this time the following are our alternatives for the 2019 conference:

• Hold it again in Pueblo August 2-4 at the library at no cost for the facility or the audio/visual technology. The agenda can be different from last year, such as a different reception and banquet venue and new tour selection.

- The opportunity to be a chapter host is open until February 15. Southern California has indicated they will not be the chapter host in 2019. The Utah chapter wants to wait until the chapter is solidified and pass for 2019. FACC has been asked and they have not said yes or no.
- Depending on what we hear from Patsy Vasquez and Margie Victoria Delgado, the options to hold it in Santa Fe and Espanola will be determined after they report back their findings to us no later than February 15.
- Wherever we hold the conference we still need one chair person or three co-chairs, as was done last year. If we get no chair person or co-chairs we can try to hire a coordinator costing us about \$1500. This person would be in charge of the duties mentioned previously but would rely on our GSHA volunteers for the tasks at hand. There are pros and cons to this.
- Bob Craig has already volunteered to be the registration chair which is very big job, and we are thankful.
- If we cannot find a paid coordinator or the board does not approve hiring a coordinator and we have no people coming forward to chair or co-chair the conference, the board has the option to cancel the conference, although we still have to have an annual meeting which can be done via teleconference.

All this has to be decided by February 15 because time is of the essence to start the planning. We will already be one month behind, but it can be done. So, we are really leaving this up to the membership and the board. We welcome your input and suggestions and hopefully, some person or persons will come forward as chair or co-chairs or we find an event coordinator. Stay tuned. I feel optimistic that we will have a great conference in 2019, but then again, "it takes a village." See Article XV printed below for guidelines. All proposed amendments must be received in writing by February 1, 2019. ARTICLE XV -- Amendments to the Bylaws and Standing Rules of Procedure

Any member in good standing desiring to offer a proposed amendment to the Bylaws and/or the Standing Rules of Procedure may petition the Rules Committee directly or through the Executive Committee no later than February 1 of each year. The petition should include a short explanation or rationale for the proposed change. The Rules Committee will submit its recommendations for Board action no later than March 31.
